Mark's Mini Academy is a free two-week introductory course designed to introduce you to steno, the steno machine, and provide an inside look at what it's like to be a court reporting student at Mark Kislingbury's Academy. M.M.A. will cover machine set up/tear down, keyboard layout, the steno alphabet, ideal hand/body posture, and a brief lesson in the basics of Mark's Magnum Steno Theory. This course will be offered onsite and online live through Zoom for those unable to attend in person.

A steno machine is required in order to participate in this course. **For onsite students** that are unable to borrow or acquire a machine for the classes, MK Academy will provide a machine for the duration of the course. This means that students who wish to participate in the course through Zoom will be fully responsible for acquiring their own machine. The number of machines MK Academy has access to is limited, which limits the number of students we can host onsite. If MKA has run out of machines for student use or you're planning on attending through Zoom, we have listed a few suggestions below:

****Onsite participants will not be permitted to take any machines that belong to MK Academy home with them. Before beginning Mark's Mini Academy, onsite students will be required to sign an acknowledgment agreement stating that they'll be fully responsible for covering repair/replacement costs if they damage a machine during M.M.A.'s two-week duration.***

Steno Practice Boards:

These practice boards **DO NOT** press down like a standard keyboard on a machine does, but it will give you a basic understanding and something to use during class if you are interested.

If you purchase/rent from one of the above options and they ask about customizations for keys, you'll want to get an extended asterisk key and an extended DZ key. **However, you do not have to have these customizations for Mark's Mini Academy. The customizations may cost extra and are not required for this intro course if you do not wish to pay for them. Mark requires students enrolling in his school to have these specific customizations, so they would be helpful to have but will not be required for M.M.A.**

iStenoPad App: *This app has been designed for the Apple iPad **ONLY**. It will not work on an iPhone or any other device.*

Frequently Asked Questions:

- 1) Where can I sign up for Mark's Mini Academy?

- 2) Will I be expected to enroll at the Academy of Court Reporting once M.M.A. concludes?

- 3) Will there be homework for this class?
 - No. M.M.A. will not be giving out any homework during the course.

- 5) Do I need to have access to one of the CAT softwares to participate in Mark's Mini Academy?

- No. We will briefly discuss software during the course but we will not be utilizing it for classes. Students will be reading raw steno and can see the English translations on the shared screen.
